(For repayment to the Federal Government of unwanted tax rebates)

Instructions

Purpose of Form

If you receive any tax refund from the Federal Government during your lifetime or after, you may use Form W-UR4KD to return that money to the government.

Exceptions

1. If you are a government employee, we cannot accept your tax refund (this includes members of Congress and and their staff).

2. If you received an Earned Income Tax Credit, we cannot accept your refund/entitlement.

3. If you are a welfare recipient, we cannot accept your money (if you wish to help your government, simply continue buying lottery tickets).

4. If you receive any form of government entitlement, we cannot accept your money.

Note: If you should win the lottery in excess of \$30,000, you will then be eligible to return any and all monies to us.

Why Should I Return My Refund?

As you may know, the Federal Government needs money in order to expand and promote voter interest (by way of entitlement programs). By returning your tax refund to us, you will ensure the continuation of basic human rights for everyone through successful government programs such as public

housing, public schools, free healthcare, government research

grants (e.g., the effect of bovine flatulance on the earth's ozone layer), the war on drugs, and farm subsidies, just to name a few.

How Much Can I Return?

If you are not listed under the "Exceptions" category, you are free to return all of your refund, plus any other money you feel is your patriotic duty to invest.

We Were Considering Buying A House.

Can We Give That Money To You Instead?

Many people feel guilty about aquiring the "better things" in life, such as a house or late-model automobile. If you find yourself in this category, by all means give that down payment to us and sleep well in the knowledge that you have done a great service for your government.

Can I Use This Form To Give You All My Money?

This form is only for the return of tax refunds. Any additional money should be returned using Form W-IM4KD, or for married couples, Form WE-R4KD.

What Do I Need To Do?

Complete lines 1-4; check one box on both lines 5 and 6; sign Form W-UR4KD; detach below the line and return to the Department of the Treasury, Internal Revenue Service, along with your refund check, your wallet, a complete set of your fingerprints, your passport, and a completed 2000 Census questionaire (the long form).
