From Your President...

This is your last official *Update* for a while. You'll find the same monthly information on the various Directors' pages on our web site (<u>www.florida-aauw.org</u>). I will be sending timely reminders and information to the presidents via e-mail, so please be sure I have an up-to-date e-mail address for you. Also, make sure when you (or your successor) fills in the 2002-03 **Branch Officers Report Form** that you include current e-mail addresses. I gave out copies of the BOR form at convention; it is also found in this *Update*, and on our web site under Members Corner. The drop dead due date is May 25, so if you have already held elections in your branch, I suggest that you send it in now.

Please note the calendar of events/deadlines included in this issue. In particular, I want to call your attention to the South Atlantic Regional Conference, to be held June 7-9 at the Embassy Suites in Tampa. I had lunch last week with the keynote speaker for the conference, Fawn Germer. Fawn is a veteran investigative reporter and a Pulitzer Prize nominee. She has been the Florida correspondent for The Washington Post and US News and World Report, as well as a staff writer for the Miami Herald, and an editor for The Tampa Tribune. She has recently written a book, Hard Won Wisdom: More than 50 Extraordinary Women Mentor You to Find Self-Awareness, Perspective, and Balance, which has been heralded as one-of-a-kind by Oprah Winfrey. It is a compilation of never-before published interviews with over 50 of today's strongest and most successful women, sharing the "sources of their strength and the secrets of their success". The book is excellent - readable, flowing and insightful. Fawn herself is delightful, slightly irreverent, and lots of fun. She will also be available for book signings and will be giving a workshop at the conference on time management.

The final date to remember is June 30. Please be sure that your branch treasurer sends her Branch Dues Report with a check to Carol Newnam, Director of Finance, by that date. Keep in mind that *FloriVision* mailing labels are sent from Washington based on the BDR's that Carol sends them. If your members are not included, they will not receive the fall issue. In a state presidents mailing, AAUW president Nancy Rustad included a quote from Meg Wheatley's new book, *Turning to One Another: Simple Conversations to Restore Hope to the Future.* I would like to close this last *Update* letter with that quote:

FLORIDA AAUW WEB SITE – A SOURCE OF IMPORTANT INFORMATION

Beginning in July the Florida AAUW Web Site will replace the *Branch Update* as a source of information about AAUW activities for all Florida AAUW members including branch presidents, branch officers and state board members. Be sure to consult it regularly to keep up with the latest news!

If you want to put information or an article on any part of the Florida AAUW web page please follow these general guidelines:

- 1. Submit articles and information regularly to make your part of the web page interesting and timely.
- 2. Use Microsoft Word, proofread, and run through spell check before emailing to the web manager as an attachment.
 - Your article (or information
 - a. Must be interesting, succinct, be time sensitive, and have wide appeal.
 - b. Include a title, the text, and your name (if you want to)
 - c. Include a date when the information should be removed from the page in the email message accompanying the attachment.
 - d. Be specific about where the material should be placed, i.e.:
 - 1. Members Corner: Calendar, Forms, etc
 - 2. Program, EF, Public Policy, LAF, etc, pages
 - 3. Branch page—Name of branch and location on that page.
- 3. The Florida AAUW home page is reserved for President's message and for brief, intriguingly written special interest items that will entice visitors to go to another area of the web site.
 - a. For special interest items provide three or four lines of text and give the
 - location of the remainder of the information.
 - b. In the same attachment provide the remainder of the text following the guide- lines listed above in item 2.
- 4. Quick changes (new phone numbers, change in dates, new email addresses, etc) should be submitted in an email message. Be specific about where the item to be changed is located.
- 5. The web manager will provide links to an email address or another related page when asked to do so. These will always appear in a different color from the text.

Our web site will be helpful and valued as an Internet destination if we keep it interesting, informative, exciting, and current. We all are responsible for our own submissions—the web manager loads them where we ask her to put them and removes them when she is asked to do so.

FLORIDA AAUW BYLAWS CHANGES APPROVED

These are changes to Florida AAUW Bylaws passed unanimously by the delegates at the April 6th Business Meeting at our 72nd Annual Convention. Please put them in the back of your state directory with the rest of the bylaws.

ARTICLE VII. OFFICERS

Section 1. Elected Officers: The elected officers of Florida AAUW shall include the president, president-elect, director for program, director for membership, director for finance, director for Educational Foundation, director for public policy, director for Legal Advocacy Fund, director for communications, secretary, and eight (8) directors-at-large.

<u>Section 4. Terms of Office</u>. The term of office shall be two (2) years, with the exception of the president-elect whose term shall be one year and begin on July 1 of the odd year. No member shall serve more than two (2) terms consecutively as an elected officer except the president and president-elect. The president and president-elect shall have served previously on the Florida AAUW board of directors and may have served two (2) terms as an elected officer.

Section 5. Vacancies.

- a. A vacancy in the office of president shall be filled for the unexpired term by the president-elect, or the director for program acting as the presiding officer until the executive committee can fill the vacancy.
- b. A vacancy in any office other than the president, which is covered in Section 5a, shall be filled for the unexpired term by the executive committee.
- c. If a president-elect leaves office before becoming president, the nominating committee shall, in preparing a slate in the even numbered year, include the office of president.

ARTICLE VIII. DUTIES OF OFFICERS

Section 1. Duties of Elected Officers.

b. <u>President-elect</u>. The president-elect shall

- (1) serve as a voting member of the board
- (2) perform such duties as may be assigned by the president and the board of directors.
- (3) act as presiding officer in the absence of the president
- (4) perform the duties of president in all cases in which the president is unable to serve
- (5) automatically becomes president without an election when the office of president becomes open.

c. Directors.

- (1) <u>Director for Program.</u> The director for program shall:
 - (a) assume the responsibility for implementing the program of FLAAUW.
 - (b) act as presiding officer in the absence of both the president and president-elect.
- (2) <u>Director for Membership</u>: The director for membership shall:
 - (b) assume responsibility for developing and maintaining membership;
 - (c) act as presiding officer in the absence of both the president, president-elect, and director for program.

ARTICLE IX. NOMINATIONS AND ELECTIONS

Section 1. Nominating Committee.

- a. There shall be a nominating committee of five (5) members elected by the following procedure:
 - c. two (2) members elected by the board of directors at the board meeting prior to the state convention; two (2) alternates may be elected also;
 - (2) three (3) members elected by the voting body at the state convention.
- b..The president shall appoint a temporary chair from among the committee members who then shall appoint a permanent chair.
- c..No branch shall be represented on the nominating committee in two consecutive years.

Section 2. Elections.

b. the president, director for membership, director for communications, director for the Educational Foundation, and the secretary shall be elected in even-numbered years. The president-elect, director for program, director for finance, director for Legal Advocacy Fund, and director for public policy shall be elected in the odd-numbered years.

ARTICLE X. BOARD OF DIRECTORS

Section 4. Ballot In the interim between meetings of the board of directors, a ballot may be taken at the request of the president on any question submitted in writing.

ARTICLE XI. EXECUTIVE COMMITTEE

Section 1. Composition. The executive committee shall be composed of the president, president-elect, director for program, director for membership, director for finance, director for the Educational Foundation, director for public policy, director for Legal Advocacy Fund, director for communications, and the secretary.

PUBLIC POLICY UPDATE Submitted by Joy Bove Lurken, Director for Public Policy

Budget Threatens Public Education

On Feb 4 President Bush submitted his fiscal year 2003 budget request to Congress. Cuts in domestic programs and the return to deficit spending are a result of the 2001 tax cuts (which AAUW opposed) and the downturn in the economy.

Since April 2001 there has been \$5 trillion decrease in the surplus (including the Social Security and Medicare surpluses.) Bush has proposed, over the next 10 years another \$800 billion in tax cuts, including a new education tax credit that was defeated. AAUW is concerned about the new tax cuts and the cuts to domestic programs.

President Bush's education budget request contains a 2.8 percent increase over FY02, barely enough to maintain current education programs. The success of the recently passed No Child Left Behind Act to improve education for underserved students rests on adequate funding for the bill's programs, yet the administration's proposal is the smallest education increase in seven years. AAUW is concerned about the lack of funding in the Bush's education budget and disappointed by decisions to eliminate AAUW priority programs in both FY02 and FY03.

The President's budget also cuts or freezes higher education and financial aid programs, including a \$10 million cut to the Child Care Means Parents in School program, which provides on-campus child care to low-income student parents.

The administration's budget request also contains a new education tax credit and a new \$50 million private school voucher demonstration project to research, develop and implement voucher programs. AAUW opposes vouchers and believes that when so many programs are proposed for elimination from the budget, initiatives to siphon federal funds from public education should not be supported.
