# The Power of One, The Might of the Many:

he election of 2000 has demonstrated the power of one vote, but it has also shown the strength of a concerted voice. The 107<sup>th</sup> Congress will have more women members than ever before. Fifty-nine (59)

women – 18 Republicans and 41 Democrats –

were elected to the House, and an unprecedented 13 women – ten Democrats and three Republicans – will hold seats in the Senate. In both chambers, every woman incumbent who ran for re-election was successful, and all six women who ran for the Senate prevailed.

This is the good news. The bad news in Florida is that we continue to battle assailants of affirmative action, choice, gun control, health screening, and equity in compensation and benefits. We continue to struggle against vouchers and inequitable and backroom redistricting. And just recently, we face an ultra-conservative minority group who pledges to unseat judges who uphold our public policy principles.

Contrary to the talking heads, pundits, and even the Senate Judiciary Committee, AAUW is not a "paid special interest group". In fact, we are a non-partisan watchdog for women's freedoms and equity. In that role, we participate with coalition groups at **Lobby Days** in Tallahassee. This year we join with the Florida Women's Consortium and the Florida Business and Professional Women from March 24-27 to

AAUW is not a "paid special interest group". In fact, we are a non-partisan watchdog for women's freedoms and equity. discuss issues and to inform our legislators about our stands on the issues. Attendees will discuss and study the issues; will hear about the new bills on the floor; will learn how to lobby; will lobby their representatives; will visit the Senate chambers; will attend a reception for

Legislators; and will have the unique experience of networking with other groups.

There is so much at stake this year that Florida AAUW is offering a special incentive. Each branch that sends one representative to Lobby Days will receive \$100 in discretionary funds. Those branches that send two or more representatives will receive \$150. Representatives must register and attend Lobby Days functions. Now is the time to be part of the "might of the many" and make our AAUW voice heard!

r. Aimee Boutin received her doctorate in French literature from Cornell University in 1998 and was hired as an assistant professor of French at Florida State University. She was awarded an American Fellowship from AAUW Educational Foundation last summer to write her first book *Maternal Echoes*. The book offers a creative method of examining French romanticism by analyzing the works of poets Desbordes-Valmore and Lamartine.

Thanks to the work I accomplished during the tenure of the fellowship the University of Delaware Press and the Associated University Presses officially accepted by manuscript. Christine A. The Florida AAUW Annual Convention will be held April 27-29, 2001 at the Sheraton Orlando North in Maitland. Rooms are \$99.00 plus tax for single or double occupancy. Suites are available for \$225. If you'd like something more exclusive ask about the Club level rooms. All rooms have voice mail, coffee makers, ironing boards, and hair dryers. The reservation deadline for these rates is Wednesday March 28th. Call 1-800-628-6660 to make your reservation. Be sure to identify yourself as attending the AAUW Convention to receive these special rates. Make a note of your confirmation number.

The hotel facilities meet our needs exceptionally well. There are plenty of separate meeting rooms for our workshops and group meals without disturbing the seating arrangements for our general sessions. In addition to the Heritage Grille Restaurant, the hotel has a cocktail lounge with a limited menu and a fast food section with pizza and sandwiches. There's also a swimming pool, poolside bar, tennis court, ATM, gift shop and valet parking.

Convention dress is casual resort wear except for the Saturday night banquet which is a bit dressier.

Nancy Lee Hurlbert, President of the Florida Women's Consortium, is our guest speaker at Saturday's Second Business Meeting. Nancy has been a resident of Broward County since 1972. She is currently Vice President of Williams, Hatfield & Stoner, Inc., an engineering consulting firm, with offices throughout Florida. Nancy has been with the firm for 27 years, beginning as an engineering technician and working



her way through the organization to vice president. She is the only woman partner in the seven-owner firm of 75-plus employees.

Florida Women's Consortium represents over a quarter of a million women including FL AAUW. She also holds the State Legislative Chair of the Florida Federation of Business and Professional Women, and is also the Legislative Chair for North Broward. She took these positions with BPW after serving as their president, from 1995-96. She is also secretary of Floridians Representing Equity and Equality (FREE) and the chair of Broward County Water Control District #2. She is currently a member of the Women's Political Caucus, Society of Women Engineers, People for the American Way, Broward County Women's History Coalition, Leadership Broward, and the American Society of Certified Engineering Technicians.

Nancy works tirelessly to promote the voices of women. She was vitally involved in the campaign of Marilyn Bonilla for US Congress in 1991-92, and more recently worked on the campaigns of Belinda Keiser, Anne Gannon, and our own FL AAUW past co-president, Helen Zientek.

aRonnia "Ronnie" Williams epitomizes the advancement of AAUW's mission, the promotion of lifelong learning and education for women, the implementation of positive societal changes. She will be our featured speaker at the Sunday morning session.

A trailblazer for AAUW, Ronnie has been her branch president, Georgia state president (96-98), Association Diversity Awareness Trainer (91-95), and currently serves as the South Atlantic Regional Director. She was the

Citizen Ambassador to the Soviet Union for the Study of Women in the Workforce in 1991.

A retired educator having served forty-three years in the public, private, and university environments, she is currently the area director for Georgia Retired Educators Association. She has worked with girls in day care, reading clinics, and Girl Scouts; with adult women she has conducted seminars throughout the world on such topics as sexual harassment, women re-entering the workplace, effective family planning, and leadership skills.

Ronnie has participated in numerous local, state, and national committees including political action, teachers' rights and responsibilities, and women's concerns. As a positive role model in her community (Valdosta, Georgia) she has developed programs to honor African-American religious and community leaders.

## AAUW Legal Advocacy Fund Beth Kern — Fighting Back and Giving Back

e are again fortunate to have a LAF plaintiff visit Florida AAUW at Convention 2001. Beth's story is just one of many that

involve sex discrimination on our country's college campuses. When she decided that it was finally time to speak out and fight back, LAF was right behind her.

Beth Kern, a former assistant professor in the Department of Accounting at the University of Notre

Dame's College of Business Administration, sued the university for sex discrimination in the denial of tenure and pay inequity – Kern v. University of Notre Dame (IN). She alleges that throughout her employment, she was subjected to a hostile work environment and was held to a higher standard than male faculty in its tenure



process, making it more difficult for her to achieve tenure. In fact, as of the date of Kern's tenure denial, Notre Dame had never granted tenure to a woman on the faculty of the College of Business Administration. To date in that college, Notre Dame has granted tenure only to women faculty who had previously been granted tenure by another college or university.

Beth settled with the university in August 1998 and although the settlement terms are confidential, she is

happy with the results. In fact, she has given back \$20,000 to LAF to help support other plaintiffs fighting for equity. "The continued support of AAUW and LAF [was] an important morale booster as well as providing much needed assistant in funding our legal and court costs," states Beth.

# Proposed Bylaw Change

10

t the Florida AAUW Board meeting on January 6, 2001, two amendments to the Florida Bylaws were approved for presentation to Florida Convention 2001 for approval by the membership. Both proposals deal with Article IX Nominations and Elections.

The first deals with Section 1. Nominating Committee. proposal is to add item f. "After utilizing alternates, if it becomes necessary to fill any vacancies on the nominating committee, the remaining committee members shall select replacement(s) following the rules listed in this section."

The rationale for this proposal is that for 2000-2001 there were two vacancies on the nominating committee because of resignations after Convention 2000. If the nominating committee is to be able to present a slate of officers, they need the input of at least five members and must have a process for replacing members who might resign.

The second proposal is from Section 2. Elections. A change is proposed for item b. as follows: "The president, director for membership, director for communications, director for the Educational Foundation, and the secretary shall be elected in the even-numbered years. The director for program, director for finance, director for public policy, and director for Legal Advocacy Fund shall be elected in the odd-numbered years."

The rationale for this proposed change is that training for the director for Educational Foundation is done by the Association in the summer of even-numbered years. The person elected to this position needs that training to effectively fulfill her responsibilities. Under the current Bylaws she is in office for a full year before she receives training.

Also the director for public policy is currently elected in evennumbered years – the years of general elections. This woman needs a year in office to learn her responsibilities before she has to organize voter education campaigns, candidate forums, etc. The proposed change would give her that year to learn and thus become more effective.

Both proposals must be approved at Florida Convention 2001 by a two-thirds (2/3) vote of those present and voting according to the Bylaws.

# Successes and Disappointments of Election 2000

The biggest success of our last general election is that the 107th Congress will have more women members than ever before. Fifty-nine women – 18 Republican and 41 Democrat – were elected to the House. An unprecedented thirteen women – 3 Republican and 10 Democrat – will hold seats in the Senate. In both chambers every woman incumbent who ran for re-election was successful, and all six women who ran for the Senate prevailed.



The disappointment, of course,

was the confusion surrounding the voting process. Florida became the brunt of many jokes, but Florida was not alone in its inability to accurately count ballots.

However, a positive from all this disconcerting fiasco is that MIT and CalTech have announced a joint effort to develop an easy, reliable and inexpensive voting system. They believe there is a technological solution that will guarantee a fair and efficient system. They hope to present their recommendations within six months so that states can have a simplified but foolproof method of voting in place by election 2004.

In Florida Governor Jeb Bush has appointed a task force to evaluate our voting systems and recommend improvements. Currently the 67 counties use eleven different systems to count votes, there is no consistency in the procedures for absentee ballots, and voter registration rolls are often inaccurate. Poll workers must be competent and well trained in all potential problems. And the position of Supervisor of Election is often only a political one, whereas it should be filled by a qualified and neutral person.

Florida AAUW is committed to remaining vigilant in seeing that the task force follows through on its recommendations to guarantee that Florida never again bungles an election. And that will be the greatest success to evolve from election 2000.
