The Withholding number cannot be used to pay Withholding until 8:30 AM the next business day.

Employer Registration

An electronic version of the UCE-151 has been submitted to the Dept. of Employment and Workforce (DEW). It will take approximately three business days for DEW to review the registration. If DEW determines that there is a liability, it will mail you an unemployment number and employer package in approximately two weeks. If you need to follow up with DEW, contact the Employer Status Department at (803) 737-3075. Currently, DEW does not return these registration numbers to SCBOS.
