## STANDING RULES OF THE LEROY RIFLE AND PISTOL CLUB

- Rule 1 All events held at the Club Shooting Range are first to be presented to the Range Director, who may seek approval of the Club leadership at the next regular meeting.
- Rule 2 All scheduled shoots and matches shall be open to the public unless otherwise stated. The event chairperson or Chief Range Officer operating the event shall have the right to refuse anyone the opportunity to participate.
- Rule 3 On days scheduled for specific events or activities, the range will be closed to all other activities subject to the discretion of that day's chief range official.
- Rule 4 Shooting at the Club range, aside from scheduled events, is for Range Members only. After successfully completing all requirements of RANGE MEMBERSHIP, members may take responsibility for inviting guest participation and for participation by their immediate family members. Prior to that, a new member can ask another Range Member to take responsibility for guest participation. Guests' activities must be personally supervised by a qualified Range Member and are subject to all rules.

Guests are defined as:

- A. A friend from another area whom you wish to entertain.
- B. A local person whom you invite with the intention he or she may become a Club member. A person may be considered a guest a maximum of three (3) appearances at the Club range. By then, it should be known if actual intentions favor membership.
- Rule 5 Those persons under the age of 18 may fire handguns or long guns if accompanied by a Range Member and a "Youth Waiver" has been previously filed.
- Rule 6 No alcohol or drugs are to be used on club grounds.
- Rule 7 No vehicle is permitted on the range proper, except an official range vehicle or work party vehicle. Parking must be in designated areas. The Range Director or a Match Director may except this for events.
- Rule 8 No hunting or trespassing is allowed on the grounds adjacent to the range. This includes all members and guests.
- Rule 9 A first aid kit, red flag, and a sign, visible for some distance, shall be displayed at the Club range, prior to shots being fired. The sign shall read DANGER-RANGE FIRING-KEEP OUT!!
- Rule 10 Discharging firearms on the rifle & pistol range begins one hour after sunrise and ends at sunset. Exceptions include:
  - 1. During times of mowing and scheduled range property maintenance.
  - 2. Pre-scheduled, the trapshooting field may be operated from one hour after sunrise until sunset, but also with a provision allowing use until 9 P.M. using special lighting for night time trapshooting events.

- Rule 11 STRICTLY PROHIBITED are: Firearms and devices specified by the NATIONAL FIREARMS ACT OF 1934, 'Hellfire' devices, firearm trigger adaptive devices allowing more than one shot to be fired by a single pull of the trigger, tracer and armor piercing ammunition and pyrotechnic items of any description.
- Rule 12 Seven (7) and twelve (12) yard metal backstops: Shoot only .22 rim fire and target grade center fire pistol ammunition. No center fire rifle bullets, shotguns, or other backstop damaging ammunition is allowed.
- Rule 13 Only Club approved targets are allowed to be fired upon. This includes paper, clay, and those targets approved by persons conducting approved matches and shoots. No non-disintegrating residual items are to remain undisposed.
- Rule 14 Smoking is prohibited inside the covered firing line.
- Rule 15 No horseplay is permitted on the range.
- Rule 16 Parents are responsible for the actions of their children. They must be kept away from the firing line, except when engaged in supervised shooting activities, and must stay within the boundaries of Club property.
- Rule 17 Pets must be kept under control at all times.
- Rule 18 The last person to leave the Club range shall see that the grounds are in order and secure.
- Rule 19 Allow no unauthorized person to be on Club property. All Range members are instructed to ask them to leave.
- Rule 20 All persons shooting at the LRPC range are to wear eye and ear protection, for insurance purposes and their own safety.
- Rule 21 General members and Range members who arrive at the Club range property to participate in any and all shooting activities must first attach their current, official name badge to their shirt or cap, with name visible from the front so that they may be easily identified by others. The wearing of the official name badge is optional and not required during organized shooting activities.
- Rule 22 A counter copy of Club Bylaws, Standing Rules, Range Safety Rules, Range Covenants, and other pertinent writings shall be located in the clubhouse and available for inspection by members.

Failure to observe and follow these rules may result in disciplinary action by the LRPC Board of Directors.
