Providing Education Patients Can Use

- Standardized patient education: 20 documents completed, including a surgical booklet and system wide cancer documents.
- Reviewed over 200 documents for health literacy - devoting 409 staff hours.
- In collaboration with Creative Services, designed patient education templates available to MaineHealth members at no cost.

Supporting Staff Resiliency

- Delivered Mindfulness workshops for staff to learn tools that will help them deal with stress and reduce burnout. Close to 100 people trained across the system.
- Trained staff at LCHC to deliver the evidence based National Wellness Institute Stress and Resiliency Program. This training helps individuals identify and practice their personal coping style and strengths.

- Responded to 2,693 requests for information.

Training for Effective Communication

- Held two SBAR trainings.
- Completed Provider Coaching program with 10 MMC and MMP physicians.
- Developed and conducted a Motivational Interviewing training for Pharmacy Enterprise.

- Produced 4 virtual
 education modules related

- Completed education modules on operational excellence, tobacco medications, and iPace methodology.
- Provided support for 14 tobacco cessation training sessions, 5 Let's Go! motivational interviewing training sessions, and 6 immunization skills lab trainings.
- Produced and delivered 135 educational opportunities to 30,235 members of our healthcare community.

Responding to Crisis

- Co-lead the Opioid Education Committee, which created 5 original patient education materials, a quarterly newsletter, web pages for patients and providers and facilitated 3 patient focus groups.
- Hosted day-long opioid conference for over 125 providers.
- Coordinated and hosted online panel presentation on e-cigarettes for 180 registrants. Also produced two vaping education documents for pediatric patients and their parents.
