## ALL ABOUT DINGWALL AND THE PLO

The basic goal of the Palestine Liberation Organization is to kill enough Jews to make them give up on Israel. Before we go further with that, let's talk about David Dingwall for a minute.

So, you can be excused for your surprise that just under half of those struggling companies have managed to funnel over a million of your dollars back to - you guessed it - the Liberal Party. For the record, the other political parties have been the recipients of about \$350,000 of largesse from 25 of the 114 companies.

Is it just me, or does the tilt of goodwill towards the Libranos seem odd? Various perusals of government websites - some of which have started deleting such information - show a pattern of giving that happens to coincide with the receipt of government loans.

These are not coincidences, as the pattern is repeated quite regularly. There is also a preponderance of Librano movers and shakers among the companies that have received TPC funds. These individuals make unusually healthy donations to the party. In the United States, for example, this type of money laundering would be prosecuted as racketeering. Congressional House Majority Leader Tom Delay is finding that out right now, actually.

The PLO (thought I had forgotten, didn't you?) is a sponsor of terrorism. It receives funds from various sources worldwide. As in the case of the Irish Republican Army, many people who donate to it through third parties don't even know they are helping to fund murderers.
