Text of Order	<p>The Governor in Council on the joint report and recommendation of the Minister of Natural Resources (the "Minister") and the Minister of the Environment dated June 20, 1996, pursuant to clauses 5(a) and (b) of Chapter 446 of the Revised Statutes of Nova Scotia, 1989, the Stora Forest Industries Limited Agreement Act, and Section II (1)(a), (c) and (e) and (2)(e) of the Water Agreement dated April 22, 1960, attached as an appendix to the said Act; clause 16(1)(a) and Section 19 of Chapter 114 of the Revised Statutes of Nova Scotia, 1989, the Crown Lands Act; Sections 56 and 103 of Chapter 1 of the Statutes of Nova Scotia 1994- 95, the Environment Act, and regulations made in respect to water approvals pursuant to the Environment Act, is pleased to: (a) authorize the Minister of Natural Resources on behalf of Her Majesty the Queen in Right of the Province of Nova Scotia to execute and deliver to Stora Forest Industries Limited at Port Hawkesbury, Richmond County ("Stora"), a warranty deed conveying title in fee simple, free from encumbrances, the lands marked in colour and shown on an overall plan attached to and forming part of the Report and Recommendation as Schedule "A", with such exceptions and limitations as the Minister of Natural Resources deems necessary to include in the deed or plans referred to in the deed, such lands being in the vicinity of Mulgrave, Guysborough County; (b) authorize the Minister of Natural Resources on behalf of Her Majesty the Queen in Right of the Province of Nova Scotia to execute and deliver to Stora a Bill of Sale, conveying whatever title She may have in personal property situate on the water supply lands referred to in paragraph (a) of this Order which personal property may now be owned by the Province and which the Minister of Natural Resources deems necessary for the delivery of water to the pulpmill operated by Stora, the list of chattels being more specifically described in Schedule "B" attached to and forming part of the Report and Recommendation with such exceptions and limitations as the Minister of Natural Resources deems necessary; (c) authorize the Minister of Natural Resources and the Minister of the Environment to issue all necessary water licences and approvals to Stora in regard to the water supply lands referred to in paragraph (a) of this Order pursuant to the Stora Forest Industries Limited Agreement Act, the Water Agreement and the Environment Act; and (d) authorize the Minister of Natural Resources, the Minister of the Environment or such other Ministers as may be deemed necessary to do every act and exercise every power and perform the acts, matters and things required by the Water Agreement, the Stora Forest Industries Limited Agreement Act, the Environment Act and this Order.</p>
